#### **Practice Facilities**

Practice will be made available at least 48 hours before start of tournament i.e. on 25<sup>th</sup> and 26<sup>th</sup> April 2024. The exact time will be updated and shared after the draw has been done. The allocating of the practice will be subjected to the approval of the Referee.

- Pre-tournament Practice: Each team will be allocated time on an equitable basis taking into account the number of players per team.
- During tournament Practice: Each team will be allocated practice time considering the requests made and the number of players per team. The allocation will be published on a day-to-day basis.
- Requests must be submitted on a day-to-day basis for the following day before 14:00 hours using the online Practice Request Form or an alternative method which will be updated during the team managers meeting.

	The <b>Thomas Cup</b> is the handsome prize awarded for the <b>World Men's Team</b> <b>Championships</b> . Its name honours Sir George Thomas, legendary Founder- President of the International Badminton Federation (now BWF), who was keen that badminton should have its own version of the Davis Cup in tennis.	
	The <b>World Women's Team Championships</b> was proposed in 1950 by England's great pre-War player Betty Uber (supported by New Zealand's Nancy Fleming), and eventually came into being in 1956-57. The trophy, whose name honours Betty Uber who donated and designed the trophy.	
ATA Carnet	The Thomas & Uber Cup travel with an ATA Carnet documentation – an ATA Carnet is like a passport for merchandise, and it is an international document that permits the tax-free and duty-free temporary admission of goods into multiple countries.
