Eligibility

Slovenian Badminton license for Slovenian players, foreign players have to be member of a Member affiliated to BWF.
According to BWF regulations - players who are under 19 years of age throughout the year 2025 (born on or later than 1st January 2007).

Entries

All entries must be made by using the BWF Online entry system.
Entries must be submitted no later than:
Tuesday 12^h August 2025 at 23:59 BWF HQ time

Draw Size

MS=64 WS=64, MD=32, WD=32, XD=32.
The maximum number of competitors (players/pairs) accepted in the tournament is 48 in the singles events, 32 in the doubles and 32 in the mixed doubles.

Limitation



In accordance with regulation § 9.2 and § 9.3 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least 8 (eight) competitors in the first published version of the main draw. If the required number of competitors is not met in the first published version of the main draw, this particular event shall not count towards any ranking.

In accordance with regulation § 9.4 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least 1 (one) entry from a Member other than the hosting Member in the first published version of the main draw. If an event does not contain at least 1 (one) entry from a Member other than the hosting Member in the first published version of the main draw, this particular event shall not count towards any ranking.

BADMINTON EUROPE is not liable for any costs incurred by third persons (players, coaches, umpires, team managers etc.) because of an event not having enough competitors to count for the rankings.

12.1 The Member that enters a player/pair into a BEC Junior Circuit tournament is

responsible for paying the entry fees for that player/pair. The entry fees become due if a player is entered and has not been withdrawn when the entry deadline passes. It is recommended that the entry fees are paid by bank transfer, but the organisers can accept cash payments at tournaments. 12.2 The entry fees will not be refunded in the case of a withdrawal. For all the withdrawn players the organisers can invoice the entry fee to the relevant Member.

12.5 Organisers are allowed to refuse entries if Members or their players have outstanding fees from a previous year.

13.1 Colour, design, lettering and advertising on clothing shall be regulated by BWF Statutes, Section 5.2.3: Junior Tournament Regulations § 12 to 16. A player violating these regulations shall be penalised by an administrative fine of 50,00 EUR.

13.2 It is mandatory for the semi-finals and finals that partners in doubles wear the same colour of the T-shirt and shorts/skirts. Failing to do so shall result in an administrative fine of 50,00 EUR.
