<b>EVENTS</b>	<p>Men's and Women's Singles, Men's and Women's Doubles and Mixed Doubles Number of players/pairs accepted for the main draw: Singles 32 and Doubles 24.</p> <p>In accordance with regulation § 9.2 and § 9.3 in BWF Statutes, Section 5.3.3.1: World Ranking System, an event must contain at least 8 (eight) competitors in the first published version of the main draw. If the required number of competitors is not met in the first published version of the main draw, this particular event shall not count towards any ranking, i.e. BEC Elite Circuit Ranking and BWF World Ranking.</p> <p>In accordance with regulation § 9.4 in BWF Statutes, Section 5.3.3.1: World Ranking System, the first published version of the main draw of an event must contain at least 1 (one) entry from a Member other than the hosting Member. If an event does not contain at least 1 (one) entry from a Member other than the hosting Member, this particular event shall not count towards any ranking.</p> <p>Badminton Europe is not liable for any costs incurred by third persons (players, coaches, umpires, team managers etc.) because of an event not having enough competitors to count for the rankings.</p>
<b>ELIGIBLE PLAYERS</b>	<p>All players of clubs affiliated through their National Associations to the BADMINTON WORLD FEDERATION.</p> <p>Victor Swedish Open 2026 is exempted from the BWF Statutes, Section 5.6.1: Participation Regulations for Individual Neutral Players and Support Personnel with a Russian/Belarusian Passport. Hence, Victor Swedish Open in 2026 is organized without the participation of Russian or Belarusian athletes or officials, regardless of their representation as neutral Players/Support Personnel.</p>

In case you wish to enter players, who do not have a BWF ID-number, please contact the BWF office well in advance of the tournament, so that the players concerned can receive a BWF ID-number before the closing date of the tournament.</p> <p>No late entries will be accepted!</p> <p>Compliance with GCR 7.9: "In making or authorizing entries, the Member concerned is reconfirming its acceptance, and acceptance by the Players being entered, of the BWF's regulations and Disciplinary processes."</p>

**ENTRY FEES**

**EUR 90 in Singles and EUR 150 per pair in doubles.**

**PAYMENT**

The Member that enters a player into a BEC Elite Circuit tournament is responsible for paying the entry fees for that player. The entry fees become due if a player is entered and has not been withdrawn when the entry deadline passes. It is recommended that the entry fees are paid by bank transfer, but the organizer accepts card payments at the tournament.

**Payment of entry fees needs to be made before 7 January 2026.** Invoices will be sent to each Member in connection with the final approval of entry list.

The entry fees will not be refunded in case of withdrawal. For all the withdrawn players the organizers can invoice the entry fee to the relevant Member. If no payment has been received after the deadline has passed, the organizers will forward the invoice with the registration of deliverance and the copy of the original entry together with the original invoice to Badminton Europe. Every unpaid invoice for entry fees sent to Badminton Europe by a tournament organizer following the above-mentioned procedure shall result in an additional administrative fine of 100 EUR for the Member who is addressed on the invoice.

If a player/pair is listed on a "Reserve List", no entry fee is to be paid before being promoted to the Main Draw or Qualification draw.

Before the withdrawal deadline has passed, a promotion from the "Reserve List" to the Main Draw or Qualification draw is obligated and will be done automatically, unless the respective player/pair has withdrawn from the "Reserve List" beforehand.

After the withdrawal deadline has passed, the organizers must have such a promotion confirmed in writing by the Member/Members of the respective player/pair before it takes place. Only when this confirmation has been given is the player/pair considered as an entry.



## INVITATION VICTOR SWEDISH OPEN 2026

Organizers are allowed to refuse entries if Members or their players have outstanding fees from a previous year.

Any withdrawal after the Monday immediately preceding the draw, for any reason whatsoever, renders the Member concerned liable to an amount of USD 150 for the inconvenience caused by the withdrawal (as defined in BWF General Competition Regulations).

Any player not showing up for a match at the tournament, without having been withdrawn in advance, renders the Member concerned liable to an additional amount of USD 500 for the inconvenience caused by the “no show” (as defined in BWF General Competition Regulations).

### DRAW

The draw will be performed by Badminton Europe.

### PRACTICE

Practice facilities will be available in the main hall before the tournament start on Wednesday evening from 6 pm to 9 pm. Practice courts are available in the arena throughout the tournament (5 courts), but not in the main hall. Prize money will be paid to bank accounts only, no cash payments. The payment will be done on the first bank day after the tournament, i.e. January 19 2026, and the organizer will also bare all costs for the money transfer. Players are required to provide bank account number, bank IBAN and SWIFT. Prize money to be paid to the players and not to the Members. Unfortunately, we cannot pay cash due to the restrictions on cash handling in Sweden. No taxes will be deducted.

### CONDITIONS OF PLAY

The tournament will be played in full accordance with the Laws of Badminton and General Competition Regulations as adopted by the BWF as well as the Regulations of the Badminton Europe Elite Circuit. In the events of any dispute, the Referee's decision shall be final.

Competitors must be prepared to play at the times quoted in the order of play for the events for which they have entered. Competitors will be excluded if not ready to play when called.

Colour, design, lettering and advertising on clothing shall be regulated by BWF General Competition Regulations § 20 to 24. Any breach of these regulations will be forwarded to BWF.



It is mandatory that partners in doubles wear the same colour of the T-shirt and shorts/skirts at all time during play in both the qualification and the main draw. Failing to do so shall result in an administrative fine of 100 EUR.

Players shall not plan their departure less than 2 (two) hours after their last match is planned to conclude. If a player is unable to compete due to early departure, he/she shall be penalised by Forfeiture of rewards (removal of Elite Circuit ranking points and shall not be awarded prizes or prize money). Badminton Europe shall propose to BWF that the gained BWF ranking points are also removed.

The organizing Member can cancel a tournament in case of force majeure. Such cancellation must be announced at least 15 days before the start of the tournament. If a cancellation is announced less than 15 days before the start of the tournament, the Member organizing the tournament is liable for any expenses incurred by third persons (players, coaches, umpires, team managers etc.). Badminton Europe is not liable for any costs incurred by third persons because of a cancellation of a tournament.

#### **DOPING CONTROL**

Doping control may be carried out by the Swedish Sports Confederation. Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

#### **BADMINTON INTEGRITY**

Section 2.4 of the BWF Statutes (Code on The Prevention of The Manipulation of Competitions) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match. Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a match(es).

There are two options to pay the hotel:

**Pre-payment** **Prepayment needs to be done 2 weeks prior to arrival.**  
Contact the hotel for bank transfer details. If the payment is not visible on the hotel account, payment will be required at check-in to get access to the rooms.

## TRANSPORT

Official point of arrival is Stockholm Arlanda Airport (ARN) or Uppsala Central Station from where transport will be provided for participants staying at the Official hotel. Transport will be provided until Monday January 19, 2026.

**NOTE!** To guarantee transportation, the transportation request must be registered at [swedishopenbadminton.com](http://swedishopenbadminton.com), **by latest January 6, 2026**.

Transportation between Arlanda – Uppsala could be arranged for a fee (50 EUR one way) for participants not staying at the official hotel, with departure after January 19 or if booking request is submitted after January 6, 2026.

No Shuttle service will be provided since the official hotel is within walking distance to the venue (150 m)

## ACCREDIT- ATION
